ORDINANCE NO. 07-021

AN ORDINANCE AUTHORIZING THE CITY MAYOR HON. ALDRIN L. SAN PEDRO TO IMMEDIATELY RELEASE THE AMOUNT OF TWENTY TWO MILLION ONE HUNDRED SIX THOUSAND ONE HUNDRED SEVENTEEN PESOS AND 88/100 (PHP22,106,117.88) FROM THE CALAMITY FUND OF THE CITY.

WHEREAS, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that, *"the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall"*:

(1)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, Section 5 (a) of Rules and Regulations implementing Republic Act 8185 states that, "allocation- the 5% calamity fund shall be set aside as annual lump sum appropriation for every calendar year in the annual budget of the local government unit to be allocated to areas affected by the disaster or calamity. Local Government Units may also allocated for the use of a portion of the 5% calamity fund to other affected areas on condition that the said areas are declared as in state of calamity by the Sangguniang Panlungsod;

WHEREAS, due to successive typhoons *Lando, Mina and Nonoy* the City of Muntinlupa has been experiencing continuous rainfall that causes the sudden rise of water level in Laguna De Bay and have caused damage to roads;

WHEREAS, the continuous heavy rains have caused flooding on the lakesides, shorelines, creek sides, and other low lying areas effected the communities settling along the lakeside from Barangay Tunasan to Barangay Sucat;

WHEREAS, on 29th day of November 2007, the Muntinlupa City Disaster Coordinating Council (MCDCC) approved Resolution No. 2007-01, entitled, "*a resolution to request the Sangguniang Panlungsod of Muntinlupa to declare several communities living along the lakesides, shorelines of Muntinlupa in eight (8) barangays from Barangay Sucat to Barangay Tunasan and other flooded prone areas in Muntinlupa City under the state of calamity due to the present flooding*";

WHEREAS, on 3rd December 2007, the 5th Sangguniang Panlungsod was approved Resolution No. 07-054, entitled, "*a resolution declaring the lakesides, shorelines, creeksides and other low-lying areas from Tunasan to Sucat, Muntinlupa City to be under a state of calamity*".

WHEREAS, as certified by the Budget Office there is an available fund from the 2007 Executive Budget under Calamity Fund of the City in the amount of Twenty Two Million One Hundred Six Thousand One Hundred Seventeen Pesos and 88/100;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the Sangguniang Panlungsod of Muntinlupa to immediately release the calamity fund for the following purposes:

1. *To purchase medicines and other medical needs;*
2. *For the immediate rehabilitations of roads, pathways, creek sides and waterways and rip raps;*
3. *For the relief operations of affected families;*
4. *For the purchase of coco lumbers, and other construction materials for temporary bridge to connect houses under waters to areas not affected by flood waters;*

ENACTED, by the 5th Sangguniang Panlungsod of Muntinlupa this 3rd day of December 2007, on its 19th Regular Session.
