ORDINANCE NO. 07-129

AN ORDINANCE GRANTING THREE THOUSAND PESOS (Php3,000.00) TO EVERY HOMEOWNER (WHOSE HOUSE WAS TOTALLY DAMAGED) AND TWO THOUSAND PESOS (Php2,000.00) TO EACH RENTER, BOARDER SHARER (WHOSE HOUSE WAS TOTALLY DAMAGED) AND ONE THOUSAND PESOS (Php1,000.00) TO EACH RENTER, BOARDER, SHARER (WHOSE HOUSE WAS PARTIALLY DAMAGED) AFFECTED BY THE FIRE ON JANUARY 29, 2007 AT PUROK 4 BLOCK 2, DULLAVIN COMPOUND, SAN GUILLERMO STREET, BAYANAN, MUNTINLUPA CITY AND ALLOCATING FIFTEEN THOUSAND (Php15,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2007 EXECUTIVE BUDGET-CALAMITY FUND.

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 states that *"the Sangguniang Panlungsod, as the legislative body of the city shall enact ordinances xxx and shall;*

" (1) (iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;"

WHEREAS, on Jan 29, 2007, there were **three(3) homeowners** (whose houses were totally damaged), **Two (2) houses renters/ sharers**, (whose houses were totally damaged), **two (2) house owners** (whose house were partially damaged) affected by the fire in *Block 2 Purok 4 Dullavin Compound, San Guillermo St. Bayanan Muntinlupa City.*

WHEREAS, there is a need for the City Government to give financial Assistance to the aforesaid victims in the amount of **Fifteen Thousand Pesos (Php15,000.00)** to be distributed as follows:

WHEREAS, the Social Services Department of the City has submitted a certified copy of the list of the homeowners and renters, sharers and boarders in coordination with the **Barangay Chairman of Bayanan Hon. Cezar Pagkalinawan** and is made an integral part of this Ordinance;

WHEREAS, there is an available fund from the Calamity Fund in the 2007 Executive Budget of the City;

RESOLVE, THEREFORE, AS IT HEREBY RESOLVED, by the members of the Sangguniang Panlungsod duly assembled to grant Three Thousand Pesos (Php3,000.00) to each homeowners (whose house was totally damaged), Two Thousand Pesos (Php2,000.00) to each renter, boarder and sharer (totally damaged) and One Thousand Pesos (Php1,000.00) to each owner, renter, boarder and sharer (partially damaged) affected by the Fire on **January 29, 2007** at **Block 2 Purok 4 Dullavin Compound San Guillermo St. Bayanan Muntinlupa City**, and allocating **Fifteen Thousand** (Php15,000.00) which amount shall be taken from the 2007 Executive Budget- Calamity Fund.

APPROVED, by the 4th *Sangguniang Panlungsod of Muntinlupa, this 1st day of February, 2007, on its 105th Regular Session.*




