AN ORDINANCE CREATING THIRTY THREE (33) DIFFERENT POSITIONS IN THE CITY HEALTH OFFICE, APPROPRIATING FUNDS THEREOF AND FOR OTHER PURPOSES.

WHEREAS, Section 458(a) (VIII) of the Local Government Code of 1991 provides that, *"the Sangguniang Panlungsod is empowered to create and determine the positions, salaries, wages, and other emoluments and benefits of officials and employees, paid wholly or mainly from the City Funds and provide for the expenditures necessary for the proper conduct of programs, projects, services and activities of the City Government;*

WHEREAS, Article 99 of the Implementing Rules and Regulations of the Local Government Code of 1991 further provides that, *"the Sangguniang Panlungsod as the Legislative Body of the City, shall enact ordinances, approve resolutions, and appropriate funds for the general welfare of the city xxx;*

WHEREAS, Article 163 of the Implementing Rules and Regulations of the same Code provides that, *"the local government unit shall design and implement its own organizational structure and staffing pattern, taking into consideration its priority needs, service requirements, and financial capabilities, consistent with the principles of simplicity, efficiency, economy, effectiveness, dynamism, and public accountability subject to the minimum standards and guidelines prescribed by the Civil Service Commission (CSC)";*

WHEREAS, one of the eight (8) point priority programs of the City Government of Muntinlupa is the health of their constituents;

WHEREAS, to further enhance the effective delivery of health services the City Government has to promote the deserving personnel in the said office;

WHEREAS, it is deemed imperative to create an additional thirty three (33) different positions in the City Health Office of Muntinlupa;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED,
by the 4th Sangguniang Panglungsod of Muntinlupa in session assembled that:

SECTION 1. Title. This ordinance shall be known as, **“An Ordinance Creating Thirty Three (33) Different Positions In Muntinlupa City Health Office Appropriating Funds Thereof And For Other Purposes.**

SECTION 2. Mandate. The City Personnel Office is hereby mandated and shall distinguish that the positions to be created in the City Health Office of Muntinlupa is in accordance with the Qualification Standards of the Civil Service Commission (CSC);

SECTION 3. Creation. The creation of Thirty Three (33) different positions in the City Health Office of Muntinlupa shall be prepared in the following : position title, number of positions be filled up, with the corresponding salary grade and total basic annual compensation appropriated, in accordance to the staffing requirements as prescribed in **Budget Circular No. 2004-3A, Conversion Of Positions Performing Staff/Non-Technical Function”.**

SECTION 4. Appropriations – Inherent to the implementation of this Ordinance which is however, subject to further evaluation and approval of both the Civil Service Commission (CSC) and the Department of Budget and Management (DBM), the City Government of Muntinlupa is hereby mandated to

appropriate the total amount of **Four Million Nine Hundred Fifty One Thousand Two Hundred Pesos (Php4,951,200.00)** shall be taken from the Executive Budget under the General Fund of the City Government.

SECTION 5. Separability Clause – If any portion of this Ordinance is declared invalid, the remainder of this Ordinance shall not be affected by such declaration and shall remain valid and enforceable.

SECTION 6. Repealing Clause – All ordinances, rules and regulations or parts thereof where provisions are in conflict with or contrary to the provisions of this Ordinance are hereby repealed, amended, or modified accordingly.

SECTION 7. Effectivity Clause -This ordinance shall take effect upon its approval.
