WHEREAS, in accordance with Ordinance No. 03-089, "an ordinance creating the Charter of the Pamantasan ng Lungsod ng Muntinlupa and converting the Muntinlupa Polytechnic College into a Local University", Article IV Section 1, states that, "*the regular meetings of the Board of Regents shall be held at least once a month at the Pamantasan ng Lungsod ng Muntinlupa or any other place in Muntinlupa City*";

WHEREAS, the *Board of Regents* of the Pamantasan ng Lungsod ng Muntinlupa is the **Policy Making Body (PMB)** of the institution;

WHEREAS, according to Ordinance No. 03-089, Article II, Section 1, the Board of Regents is composed of the following members:

1. The City Mayor who shall be automatically be the Chairman of the Board of Regents. - Php5,000.00
2. The Vice Mayor who shall be the Vice Chairman. - Php5,000.00
3. The President of the Pamantasan as Member. - Php5,000.00
4. The Chairman of the Committee on Education - Php5,000.00
5. The President of a reputable private company in Muntinlupa. - Php5,000.00

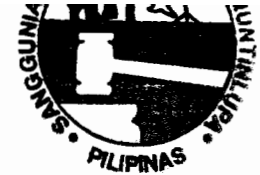

- 6. The Director of the Commission on Higher Education (CHED) in the National Capital Region as Member. - Php5,000.00
 - 7. The Director of the Technical Education and Skill Development Authority (TESDA) in the National Capital Region as member. - Php5,000.00
 - 8. The Superintendent of the City Schools of Muntinlupa who shall serve as the representative Of the Department of Education, Culture and Sports (DECS) in the BOR as Member - Php5,000.00
 - 9. The Faculty Representative of the University - Php5,000.00
 - 10. The Student Council Representative of the University. - Php5,000.00
 - 11. One representative from the Non-Governmental or People's Organizations (NGO's/PO's) in Muntinlupa to represent the private sector who shall be appointed by the City Mayor. - Php5,000.00
- Total: Php55,000.00**

WHEREAS, the total Honorarium for all the members of the Board of Regents shall be Six Hundred Sixty Thousand Pesos (P660,000.00) per year;

WHEREAS, the approved honorarium shall be taken from the General Fund as extra essential work incentive and shall be included in the Annual Budget Appropriation;

WHEREAS, as a tribute to the members of the Board of Regents the grant of honorarium is a symbol of gratitude of the institution as well as the City Government of Muntinlupa for the invaluable contribution of its members to the aforesaid institution;

WHEREAS, copies of this Ordinance shall be furnished the Office of the City Budget Officer, the City Treasurer, the City Accountant and the City Auditor for their information and appropriate action.

ENACTED, by the 5th *Sangguniang Panlungsod of Muntinlupa* this 14th day of *January, 2008*, on its 20th *Regular Session*.
