WHEREAS, Article 99, Rule IX, (1) (ix), of Rules and Regulations Implementing the Local Government code of 1991, states that, **"the Sangguniang Panlungsod shall approve ordinances and pass resolutions necessary for an efficient and effective city government and relative thereto shall, "authorize the payment of compensation to a qualified person xxx or grant honorarium to any qualified official xxx in a concurrent capacity, at the rate authorized by law.";**

WHEREAS, the PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) have five (5) members there are the following:

1. **Three (3) members coming from the NGO/PO;**
2. **The Chairman of the Committee on Public Order Security and Safety;**
3. **The Representative from the Liga ng mga Barangay.**

WHEREAS, the approved honorarium shall be taken from the General Fund as extra essential work incentive and shall be included in the Annual Budget Appropriation;

WHEREAS, as a tribute to the members of the PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) the grant of honorarium is a symbol of gratitude of the City Government of Muntinlupa for invaluable contribution of its members for the maintenance of Peace and Order in the City;




