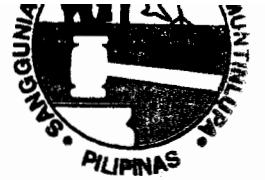

**AN ORDINANCE APPROPRIATING THE AMOUNT OF SIXTY FOUR THOUSAND PESOS (Php64,000.00) FOR FAMILIES AFFECTED BY THE FIRE ON JANUARY 14, 2008 AT PUROK 4, PNR SITE, SUCAT, CITY OF MUNTINLUPA WHICH AMOUNT SHALL BE TAKEN FROM THE 2008 EXECUTIVE BUDGET UNDER CALAMITY FUND.**

**WHEREAS**, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall":

**(1)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.**

**WHEREAS**, on **January 14, 2008** six (6) homeowners whose houses were totally damaged, three (3) house sharers whose houses were totally damaged, one (1) house owner whose house was partially damaged, three (3) house sharers whose houses were partially damaged and three (3) house renters were affected by the fire in Purok 4, PNR Site, Sucat, Muntinlupa City;

**WHEREAS**, the Social Services Department (SSD) recommended to declare the affected area as in **a state of calamity**;

**WHEREAS**, the 5<sup>th</sup> Sangguniang Panlungsod passed a Resolution No. 08-062, "A resolution declaring the area affected by the fire on January 14, 2008 at Purok 4, PNR Site, Sucat, Muntinlupa City, as in a state of calamity";

**WHEREAS**, there is a need for the City Government to give financial assistance to the aforesaid victims in the amount of **Sixty Four Thousand Pesos** (Php 64,000.00) to be distributed as follows:

**WHEREAS**, the Social Services Department (SSD) of the City has submitted a certified copy of the list of the homeowners, renters, sharer (totally damaged and partially damaged) in coordination with the Barangay Officials is made an integral part of this ordinance;

**WHEREAS**, there is an available fund from the Calamity Fund in the 2008 Executive Budget of the City;

**RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod duly assembled to appropriate the amount of **Sixty Four Thousand Pesos (P64,000.00)** for families affected by the fire on **January 14, 2008** at **Purok 4, PNR Site, Sucat, City of Muntinlupa** which amount shall be taken from the 2008 Executive Budget under Calamity Fund.

**ENACTED**, by the 5<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 28<sup>th</sup> day of **January 2008**, on its **22<sup>nd</sup> Regular Session**.






