ORDINANCE NO. 08-035

AN ORDINANCE REVERTING THE AMOUNT OF ONE BILLION PESOS (Php1,000,000,000.00) INITIALLY APPROPRIATED WITH ORDINANCE NUMBER 08-013 FOR THE CONSTRUCTION OF THE NEW CITY HALL AT BARANGAY ALABANG TO THE GENERAL FUND OF THE CITY.

WHEREAS, Section 322 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, *“unexpended balances of appropriations authorized in the annual appropriations ordinance shall revert to the unappropriated surplus of the general fund at the end of the fiscal year and shall not thereafter be available for expenditures except by subsequent enactment, however, appropriations for capital outlay shall continue and remain valid until fully spent, reverted or the project is completed, reversions of continuing appropriations shall not be allowed unless obligations therefore have been fully paid or otherwise settled.”*

WHEREAS, in accordance with Section 15 of City Ordinance No. 08-013, *“Use of Appropriated Funds - All appropriations provided for capital or development projects, priority budgetary programs and activities, shall be released and used solely for their intended purpose (s) for which the same are appropriated, except as maybe otherwise modified by the Sangguniang Panlungsod through the enactment of Supplemental Budget Ordinances.”;*

WHEREAS, on August 6, 2007, the Sangguniang Panlungsod of Muntinlupa approved Resolution No. 07-008, entitled, *“a resolution authorizing the City Mayor Hon. Aldrin L. San Pedro to secure or obtain a loan in any reputable banking institution in the amount of One Billion Pesos (Php1,000,000,000.00) for the construction of New City Hall Building of the City of Muntinlupa”;*

WHEREAS, it is not necessary at this point in time to construct the New City Hall Building at Civic Center, Filinvest Corporate City, Alabang because the renovated old city hall building is sufficient to cater and accommodate the needs of the constituents of the City of Muntinlupa and adjacent places who need the services of city government;

WHEREAS, all continuing appropriations and the corresponding obligations thereof of the City Government of Muntinlupa have been fully paid and settled;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 5th Sangguniang Panlungsod of Muntinlupa, in session assembled that:

Section 1. The amount of ONE BILLION PESOS (Php1,000,000,000.00) constituting the unexpended balance of Capital Outlay is hereby reverted to the General Fund for appropriations of the City of Muntinlupa, to wit:

1. ENGINEERING OFFICE - Php 1,000,000,000.00
2. Project's Name – CONSTRUCTION OF NEW CITY HALL BUILDING

TOTAL FUNDS AVAILABLE FOR REVERSION – Php1,000,000,000.00

Section 2. The Attached Statement of Funds Available for Reversion shall form part of this Ordinance.

Section 3. This Ordinance shall take effect upon approval.

Section 4. All Resolutions and Ordinances which are inconsistent with or not in accord with this Ordinance is deemed repealed and therefore unenforceable.

ENACTED, by the 5th Sangguniang Panlungsod of Muntinlupa this 31st day of **March 2008**, on its 12th Special Session.




