**ORDINANCE NO. 08-036**

**AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE BILLION PESOS (Php1,000,000,000.00) AS SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2008, OF THE CITY OF MUNTINLUPA, WHICH SHALL BE FUNDED FROM THE TOTAL AMOUNT DULY CERTIFIED BY THE CITY TREASURER AS FUNDS AVAILABLE FOR APPROPRIATION AMOUNTING TO ONE BILLION PESOS.**

**WHEREAS**, Section 321 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in part, states that *"No ordinance providing for a supplemental budget shall be enacted except when supported by funds actually available as certified by the Local Treasurer or by new revenue sources;*

**NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED**, by the 5<sup>TH</sup> Sangguniang Panlungsod of Muntinlupa, in session assembled that:

**Section 1.** The amount of **ONE BILLION PESOS** be appropriated as Supplemental Budget No. 01 of the City of Muntinlupa for Calendar Year 2008 duly certified by the City Treasurer as funds actually available for appropriation.

The herein appropriations of funds represents budgetary support for the continued operation of various departments/offices obligation of the City Government of Muntinlupa and infrastructure projects for which the following sums are provided by classification.




