ORDINANCE NO. 08-040

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED SEVENTY SEVEN THOUSAND PESOS (PH177,000.00) FOR FAMILIES AFFECTED BY THE FIRE ON APRIL 20, 2008 AT ILANG-ILANG ST., LAKEVIEW HOMES, PUTATAN, MUNTINLUPA CITY WHICH AMOUNT SHALL BE TAKEN FROM THE 2008 EXECUTIVE BUDGET UNDER THE CALAMITY FUND.

WHEREAS, Section 458 (a)(l)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall":

(l)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

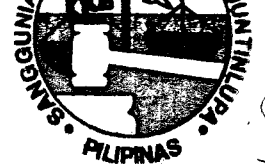
WHEREAS, on **April 13, 2008**, there were nine (9) houses gutted by the fire and forty two (42) families were affected by the fire in Ilang-Ilang, Lakeview Homes, Putatan, Muntinlupa City;

WHEREAS, the owner of the houses, renters, and sharers were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Services Department (SSD) recommended to declare the affected area as in **a state of calamity**,

WHEREAS, the 5th Sangguniang Panlungsod passed a **Resolution No. 08-125**, A resolution declaring the area affected by the fire on April 20, 2008 at Ilang-Ilang St., Lakeview Homes, Putatan, Muntinlupa City, as in a state of Calamity";

WHEREAS, the Social Services Department (SSD) of the City has submitted a certified copy of the list of the homeowners, renters, sharer (totally damaged and partially damaged) in coordination with the Barangay Chairman of Putatan is made an integral part of this ordinance;




