**WHEREAS**, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that, *"the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall"*:

*(1)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.*

**WHEREAS**, on **April 26, 2008**, there were **seven (7) houses** gutted by the fire and **forty four (44) families** were affected by the fire in Prinza, Sto. Niño, Poblacion, Muntinlupa City ;

**WHEREAS**, the owner of the houses, renters, and sharers were rendered homeless by reason of the said conflagration;

**WHEREAS**, the Social Services Department (SSD) recommended to declare the affected area as in **a state of calamity**;

**WHEREAS**, the 5<sup>th</sup> Sangguniang Panlungsod passed a **Resolution No. 08-126**, A resolution declaring the area affected by the fire on **April 26, 2008** at **Prinza, Sto. Niño, Poblacion, Muntinlupa City**, as in a state of Calamity";

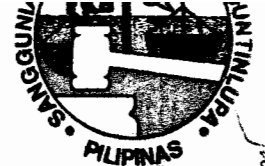




