**WHEREAS**, pursuant to the above provisions of the Constitution and of the Local Government Code, and the dream of the City Government in establishing for its constituents a comprehensive health services, the Ospital ng Muntinlupa (OSMUN) was established at the Civic Center, Filinvest Corporate City Barangay Alabang, Muntinlupa City;

**WHEREAS**, it is deemed important that the hospital vision and mission be responsive to the kind of healthcare services envisioned by the City Government of Muntinlupa;

**WHEREAS**, to set the overall direction of the Hospital as a public tertiary medical institution dedicated to the delivery of quality health care services to the less privilege members of the community, the City Government of Muntinlupa shall adopt the following vision and mission for Ospital ng Muntinlupa;

- 3. Ospital ng Muntinlupa is committed to deliver quality health services thru its competent compassionate health professionals and technologically advance medical facilities;**

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 5<sup>th</sup> Sangguniang Panlungsod of Muntinlupa to amending Ordinance No. 06-084, entitled, "an ordinance adopting the Mission and Vision of the City of Muntinlupa for the Ospital ng Muntinlupa".
