ORDINANCE NO. 08-045

AN ORDINANCE GRANTING A MONTHLY ALLOWANCE SUSTAINABLE TO MUNTINLUPA POLICE RETIREES TO BE KNOWN AS THE ALAY SA PULIS NA RETIRADO-TULONG AT BENEPISYO PROGRAM TO ITS LEGITIMATE SURVIVING MEMBERS AND THEIR WIDOWS/WIDOWERS WHO SERVED IN THE CITY OF MUNTINLUPA FOR FIFTEEN (15) YEARS OR MORE UPON REACHING THE AGE OF SIXTY (60).

WHEREAS, Article 99, (1) (viii), of Rules and Regulations Implementing the Local Government Code of 1991, states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants xxx and shall (viii) **"determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide expenditure necessary for the proper conduct of programs, projects, services, and activities of the city government"**;

WHEREAS, the police plays vital role in the progress and economic stability of a community as it serves as an arm that maintains peace and order situation;

WHEREAS, the city government of Muntinlupa desire to grant financial assistance to the Muntinlupa Police Retirees and their widows/widowers who served in the City of Muntinlupa for fifteen (15) years or more upon reaching the age of sixty (60);

WHEREAS, qualified and legitimate members of the Muntinlupa City Police Retirees are recognized by the City Government of Muntinlupa by way of granting benefit/assistance accorded to them;

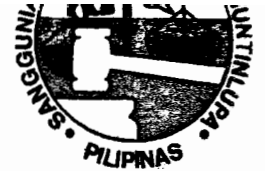

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED,
by the 5th Sangguniang Panlungsod of Muntinlupa in session assembled that:

SECTION 1. Title – this ordinance shall be known as the **Alay Sa Pulis na Retirado-Tulong at Benepisyo Program** to its legitimate surviving members and their widows/widowers who served in the City of Muntinlupa for fifteen (15) years or more upon reaching the age of sixty (60).

SECTION 2. Appropriation – the fund for the said assistance shall be incorporated to the preparation of the 2009 Executive Budget and the year thereafter subject for availability of funds.

SECTION 3. Coverage – this ordinance shall cover only those legitimate members and its widows/widowers of the Muntinlupa City Police Retirees.

SECTION 4. It shall hereby be declared the policy of the City Government of Muntinlupa to give financial assistance to the surviving Police who had served in the City of Muntinlupa for fifteen years, upon reaching the age of sixty and shall receive the amount of **Two Thousand Pesos (Php2,000.00)** monthly **Alay Sa Pulis na Retirado-Tulong at Benepisyo Program** while its widows/widowers shall receive **One Thousand Pesos (1,000.00)** per month.

SECTION 5. The **Executive Department** shall prepare the **Implementing Rules and Regulations (IRR)** for the proper implementation of this Ordinance.

SECTION 6. Effectivity Clause - This ordinance shall take effect on the 2009 Executive Budget and the year thereafter.

ENACTED, by the 5th Sangguniang Panlungsod of Muntinlupa this 23rd day of **June, 2008** on its 37th Regular Session.
