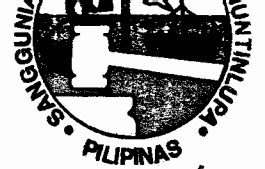

WHEREAS, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall".

(1)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on June 21, 2008, the City of Muntinlupa suffer and affected by the typhoon Frank;

WHEREAS, for humanitarian reason, the City Government of Muntinlupa through the 5th Sangguniang Panlungsod hereby allocated Seventeen Million Pesos (Php17,000,000.00) as assistance to the victims affected by "typhoon Frank";

WHEREAS, typhoon Frank caused floods, loss of shelters, lives, properties, injuries and other calamities that require clearing out operations, rehabilitation of damaged properties and evacuation of affected families of the city;

WHEREAS, on June 23, 2008, the 5th Sangguniang Panlungsod of Muntinlupa approved Resolution No. 08-154, declaring the whole/entire City of Muntinlupa as in **state of calamity**,


WHEREAS, there is an available funds from 2008 Executive Budget under Calamity Fund;
