AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 IN THE AMOUNT OF SIXTY TWO MILLION FIVE HUNDRED SIXTY SIX THOUSAND EIGHT HUNDRED TWENTY SEVEN PESOS AND 20/100 (PHP62,566,827.20) TO BE TAKEN FROM THE GENERAL FUND.

WHEREAS, pursuant to Section 319 of R.A 7160, otherwise known as the New Local Government Code of 1991, provides that, **“Legislative authorization of the budget – on or before the end of the current fiscal year, the Sangguniang Panlungsod shall enact, through an ordinance, the annual budget of the Local Government Unit for the ensuring fiscal year on the basis of the estimates of income and expenditures submitted by the Local Chief Executive”**;

WHEREAS, the said budget has taken effect at the beginning of the current fiscal year;

WHEREAS, pursuant to Section 321 of the same Code in part, states that, **“no ordinance providing for a supplemental budget shall be enacted except when supported by funds actually available as certified by the Local Treasurer or by new revenues sources”**;

WHEREAS, pursuant to Article 99, 2(i) of Implementing Rules and Regulations of the same Code, the Sangguniang Panlungsod, **“shall approve the annual and supplemental budgets of the city government and appropriated funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants”**;

WHEREAS, the Hon. City Mayor Aldrin L. San Pedro has submitted a proposed Supplemental Budget No. 2 dated July 1, 2008 in the amount of **Sixty Two Million Five Hundred Sixty Six Thousand Eight Hundred Twenty Seven Pesos And 20/100 (Php62,566,827.20)**;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 5th Sangguniang Panglungsod in session assembled that:

SECTION 1. The Supplemental Budget No. 2 is hereby approved in the amount of **Sixty Two Million Five Hundred Sixty Six Thousand Eight Hundred Twenty Seven Pesos And 20/100 (Php62,566,827.20)** to be taken from the General Fund of the City.
