ORDINANCE NO. 08-052

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED FIFTY FIVE THOUSAND PESOS (PH155,000.00) FOR FAMILIES AFFECTED BY THE FIRE ON AUGUST 13, 2008 AT MAGDAONG DRIVE, NBP RESERVATION, POBLACION, MUNTINLUPA CITY WHICH AMOUNT SHALL BE TAKEN FROM THE 2008 EXECUTIVE BUDGET UNDER THE CALAMITY FUND.

WHEREAS, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that, *"the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx, and"*:

(1)(iv) shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on August 13, 2008, there were sixteen (16) houses gutted by the fire, twenty four (24) families, one (1) casualty and two (2) injured were affected by the fire in Magdaong Drive, NBP Reservation, Poblacion, Muntinlupa City;

WHEREAS, the owner of the houses, renters, and sharers were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Welfare and Development Office (SWDO) recommended to declare the affected area as in **a state of calamity**;
