AN ORDINANCE APPROPRIATING THE AMOUNT OF FIFTEEN MILLION FIVE HUNDRED PESOS (PHP15,000,500.00) FOR THE CONSTRUCTION OF TEMPORARY FOOT BRIDGE IN DISTRICT 1 AND II, MUNTINLUPA CITY, AND FOR OTHER PURPOSES WHICH SHALL BE TAKEN FROM THE 2008 EXECUTIVE BUDGET UNDER THE CALAMITY FUND.

**WHEREAS**, Section 458 (a)(l)(iv), of the Local Government Code of 1991 states that, *"the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall"*:

*(l)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.*

**WHEREAS**, on October 15, 2008, the 5<sup>th</sup> Sangguniang Panglungsod approved **Resolution No. 08-209** declaring the lakesides, shorelines and creeksides and other low-lying areas of the different barangays in Muntinlupa City as in a state of calamity due to the overflow and/or unusual rise of water that caused flood and disturbances in the said areas.

**WHEREAS**, there is an overflow of water along the shores of Laguna de Bay that affects the residents of Muntinlupa City, particularly those living along the lakesides, shorelines and creeksides;

**WHEREAS**, big parts of the nine barangays of Muntinlupa City are now affected by the overflow of water caused by the continuous heavy rains and complicated by the closure of Napindan Channel in Taguig City;

**WHEREAS**, the overflow of water severely affected and caused difficulties to the residents of the affected areas, their families, farmers, small fishermen, students, motorists and people who have activities in the area;

**WHEREAS**, the sidewalks, pathways and improvised bridges are now under water;

**WHEREAS**, as a whole, the lives and limbs of the people in the affected areas if not given immediate care and assistance by the City Government of Muntinlupa, their health, sanitation, means of livelihood and education are in jeopardy;

**WHEREAS**, the flooding in the said areas had caused difficulties and hardship to students, factory workers and residents residing along the shoreline of Laguna de Bay;

**WHEREAS**, there is a need for the immediate release of the Calamity Fund for the following reasons:

- a) *For the immediate rehabilitation of roads, pathways, creeksides and waterways, rip raps.*
- b) *For the purchase of lumber and other construction materials for temporary bridge to connect houses underwater to areas not affected by flood waters.*
- c) *And others that are necessary to assure the health, sanitation and welfare of the people in affected areas.*

**WHEREAS**, there is an available fund from the 2008 Executive Budget under the Calamity Fund;

**NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED**, by the 5<sup>th</sup> Sangguniang Panlungsod of Muntinlupa to appropriate the amount of Fifteen Million Five Hundred Pesos (Php15,000,500.00) for the construction of footbridge in District I and II, Muntinlupa City, and for other purposes which shall be taken from the 2008 Executive Budget under the Calamity Fund.

**ENACTED**, by the 5<sup>th</sup> *Sangguniang Panlungsod of Muntinlupa* this 15<sup>th</sup> day of *October 2008*, on its 17<sup>th</sup> *Special Session*.
