WHEREAS, Ordinance No. 08-042, entitled, "an ordinance amending ordinance no. 98-008, otherwise known as the "Iskolar ng Bayan Ordinance" providing additional incentives to the scholars and for other purposes.";

WHEREAS, Ordinance No. 08-042 is being amended specifically **Section 1. a.2** due to budget constrains upon the recommendation of the City Budget Office;

WHEREAS, Section 1.a.2 of Ordinance No. 08-042 to be amended read as follows:

"Section 1. a.2 Benefits;

First Coverage: First (1st) year studies only;

- Free matriculation fees;

Second Coverage: Second to Fourth year (2nd – 4th) studies only;

- Free matriculation fees per semester (exclusive of miscellaneous fees);
- ₱ 1,000.00 book allowance per semester;
- ₱ 1,000.00 uniform allowance per semester;

- Free Tuition fees only (exclusive of miscellaneous fees);

Second Coverage: Second to Fourth year (2nd – 4th) studies only;

- Free Tuition fees per semester only (exclusive of miscellaneous fees);

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED,
by the 5th Sangguniang Panlungsod in session assembled that:

SECTION 1. Title - This ordinance shall be known as "an ordinance amending section 1 (a.2) of ordinance no. 08-042, otherwise known as the "iskolar ng bayan program", providing for additional incentives to the scholars and for other purposes.

SECTION 2. Copy of this ordinance shall be furnished the Pamantasan ng Lungsod ng Muntinlupa (PLMUN) Administration and the Muntinlupa Scholarship Program.

SECTION 3. Separability Clause – If for any reason or reasons any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof are not affected thereby shall continue to be in full force and effect.

SECTION 4. Effectivity Clause - This ordinance shall take effect on School Year 2009-2010.
