WHEREAS, the issuance of *Presidential Proclamation No. 367*, series of 1989 declares December 2-8 of every year as **Urban Poor Solidarity Week (UPSW)**, with intention to foster unity, dialogue and cooperation among government agencies, non-government agencies and the urban poor communities in specific programs and projects for the alleviation of urban poverty;

WHEREAS, *Presidential Proclamation No. 367*, encourages all government departments, agencies, and offices, and non-governmental organizations to participate in the week-long participation;

WHEREAS, the **Presidential Commission for the Urban Poor (PCUP)** has been mandated by the said proclamation to initiate the activities for the observance of the Urban Poor Solidarity Week (UPSW);

WHEREAS, the **City of Muntinlupa** has been active in its participation in the annual commemoration of the **Urban Poor Solidarity Week (UPSW) Celebration** of the country, through its *one-day* activity within the week-long celebration, dubbed as the **Urban Poor Solidarity Day (UPSD)**;

WHEREAS, the annual celebration of the **Urban Poor Solidarity Day (UPSD)** by the City, in the past several years, has proven an effective mechanism to put together the efforts of the local government unit, non-government organizations, and associations of the urban poor;

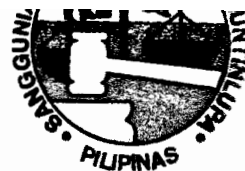
