A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ALDRIN L. SAN PEDRO TO ENTER INTO A CONTRACT IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH EXPEDITION CONSTRUCTION CORPORATION FOR GARBAGE COLLECTION AND DISPOSAL SERVICES FOR THE YEAR 2008 AMOUNTING TO TEN MILLION EIGHT HUNDRED SEVEN THOUSAND, EIGHTY THREE PESOS AND 33/100 (PHP10,807,083.33) WITH THE TOTAL AMOUNT OF ONE HUNDRED EIGHTEEN MILLION EIGHT HUNDRED SEVENTY SEVEN THOUSAND NINE HUNDRED SIXTEEN PESOS AND 67/100 (PHP118,877,916.67) FROM JANUARY 30, 2008 TO DECEMBER 31, 2008.

WHEREAS, the detailed evaluation of bids conducted on December 21, 2007 resulted in the following:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with the lowest calculated Bid, Expedition Construction Corporation, its bid has been found to be responsive;

WHEREAS, the Bids and Awards Committee declared Expedition Construction Corporation as the winning bidder for the contract for garbage collection and disposal Services of the City of Muntinlupa for the FY 2008;

WHEREAS, the said contract shall be effective from January 30, 2008 to December 31, 2008;

WHEREAS, there is a budget appropriated for the garbage collection and Disposal Services amounting to One Hundred Thirty Million Pesos (Php130,000,000.00) under the 2008 Executive Budget as certified by the Budget Office;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor Aldrin L. San Pedro to enter into a contract in behalf of the City Government of Muntinlupa with Expedition Construction Corporation in garbage hauling, collection and disposal services for the fiscal year 2008 amounting to **Ten Million Eight Hundred Seven Thousand, Eighty Three Pesos and 33/100 (Php10,807,083.33)** with the total amount of **One Hundred Eighteen Million Eight Hundred Seventy Seven Thousand Nine Hundred Sixteen Pesos and 63/100 (Php118,877,916.63)** from January 30, 2008 to December 31, 2008 or for a period of eleven (11) months .
