**AN ORDINANCE GRANTING ADDITIONAL ALLOWANCE AMOUNTING TO ONE THOUSAND FIVE HUNDRED (PHP1,500.00) EACH TO THE CONSULTANTS OF THE MAYOR'S OFFICE, VICE-MAYOR'S OFFICE AND THE SANGGUNIANG PANLUNGSOD RESEARCHER AND ONE THOUSAND PESOS (PHP1,000.00) EACH TO THE KABALIKAT, MUNTINLUPA COMPOSITE BAND, CITY BRASS BAND, HIMIG MUNTINLUPA (NON-EMPLOYEES) AND BARANGAY HEALTH WORKERS (BHW).**

**WHEREAS**, under the Local Government Code of 1991, as amended, provides that, "the City Council as the legislative body of the city has the power to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from the city funds";

**WHEREAS**, DBM Circular No. 2005-6 dated October 28, 2005, provides the payment of 13<sup>th</sup> month pay and cash gift incentives to the government employees and the said circular specifies government employees who are not entitled to 13<sup>th</sup> month pay;

**WHEREAS**, the Local Finance Committee recommend to grant additional allowance amounting to One Thousand Five Hundred (Php1,500.00) each to the Consultants of the Mayor's Office and Vice-Mayor's Office and Sangguniang Panlungsod Researcher and One Thousand Pesos (Php1,000.00) each to the Kabalikat, Muntinlupa Composite Band, City Brass Band, Himig Muntinlupa (Non-Employees) and Barangay Health Workers (BHW);

**WHEREAS**, the City Government of Muntinlupa has a number of employees, assigned to various offices, who are not entitled to 13<sup>th</sup> month pay, they are the following:

**WHEREAS**, due to economic crisis now there is a need to be granted with additional allowance in the amount of **One Thousand Five Hundred (Php1,500.00)** each to the Consultants of the Mayor's Office and Vice-Mayor's Office and Sangguniang Panlungsod Researchers and **One Thousand Pesos (Php1,000.00)** each to the Kabalikat, Muntinlupa Composite Band, City Brass Band, Himig Muntinlupa (Non-Employees) and Barangay Health Workers (BHW);

**WHEREAS**, the application for this payment is based on the preceding semesters qualification is based on employees hired on or before January 2, 2008 and must be in active service as of December 31, 2008;

**NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED**, by the 5<sup>th</sup> Sangguniang Panlungsod in session as assembled that:

**SECTION 1.** This additional allowance amounting to **One Thousand Five Hundred (Php1,500.00)** each to the Consultants of the Mayor's Office, Vice-Mayor's Office and the Sangguniang Panlungsod Researcher and One Thousand Pesos (Php1,000.00) each to the Kabalikat, Muntinlupa Composite Band, City Brass Band, Himig Muntinlupa (Non-Employees) and Barangay Health Workers (BHW).

**SECTION 2.** The additional allowance shall be given to the employees on or before December and **every year thereafter**.

**SECTION 3. Appropriation** - The City Government shall allocate/appropriate the additional allowance for the employees who are not entitled to 13<sup>th</sup> month pay in the Executive Budget **every year**.

**SECTION 4. Effectivity Clause** - This ordinance shall take effect after its approval.

**ENACTED**, by the 5<sup>th</sup> **Sangguniang Panlungsod of Muntinlupa** this 10<sup>th</sup> day of **November, 2008**, on its 57<sup>th</sup> **Regular Session**.






