WHEREAS, under the Local Government Code of 1991, as amended, provides that, *"the City Council as the legislative body of the city has the power to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from the city funds"*;

WHEREAS, DBM Circular No. 2005-6 dated October 28, 2005, provides that, *"the payment of 13th month pay and cash gift incentives to the government employees and the said circular specifies government employees who are not entitled to 13th month pay"*;

WHEREAS, the Pamantasan ng Lungsod ng Muntinlupa (PLMun) which is under the City Government has a number of part-time faculty and staff who are not entitled to 13th month pay, to wit:

- a) Part-time Faculty - 170
- b) Part-Time Staff - 73

WHEREAS, the abovementioned faculty and staff maybe given additional allowance by the City Mayor as practiced in the past;

WHEREAS, due to economic crisis and spirit of the season and in appreciation of their continued support to the quality tertiary education for the youth, it is necessary to grant them additional allowance in the amount of *Five Thousand Pesos (Php5,000.00)*;

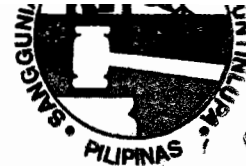

WHEREAS, the application for this payment is based on the preceding semesters qualification based on employees hired on or before January 2, 2008 and must be in active service as of December 31, 2008;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 5th Sangguniang Panlungsod in session as assembled that:

SECTION 1. This additional allowance amounting to **Five Thousand Pesos (Php5,000.00)** shall be given to each Part Time Faculty and Staff of Pamantasan ng Lungsod ng Muntinlupa (Plmun)

SECTION 2. The additional allowance shall be given to the employees on or before December 2008.

SECTION 3. Appropriation - The City Government shall allocate/appropriate the additional allowance for the employees who are not entitled to 13th month pay in the Executive Budget.

SECTION 4. Effectivity Clause - This ordinance shall take effect after its approval.

ENACTED, by the 5th **Sangguniang Panlungsod of Muntinlupa** this 8th day of **December, 2008**, on its 20th **Special Session**.

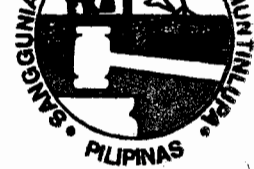
