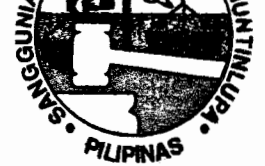

***“shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and the aftermath of said disasters or calamities and their return to productive livelihood following said events”;***

**WHEREAS, on June 21, 2008, the City of Muntinlupa suffer and affected by the typhoon Frank;**

**WHEREAS, typhoon Frank caused floods, loss of shelters, properties, injuries and other calamities that require clearing out operations, rehabilitation of damaged properties and evacuation of affected families of the city;**

**WHEREAS, the Social Welfare and Development Office (SWDO) recommended to declare the affected areas as in a state of calamity;**

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the members of the 5<sup>th</sup> Sangguniang Panlungsod, to declare the entire/whole City of Mutinlupa affected by the typhoon frank as in a state of calamity.**
