**WHEREAS**, Section 458 (a)(I)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx, and":

**(I)(iv) shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.**

**WHEREAS**, on August 13, 2008, at Magdaong Drive, NBP Reservation, Poblacion, Muntinlupa City, a fire totally destroyed sixteen (16) houses, affected twenty four (24) families, for a total of one hundred one (101) persons;

**WHEREAS**, the fire also caused the death of one (1) person and cause the injuries of two (2) persons;

**WHEREAS**, on August 13, 2008 at Magdaong Drive, NBP Reservation, Poblacion, Muntinlupa City, a fire totally destroyed and affected twenty four (24) houses;

**WHEREAS**, the **Social Welfare and Development Office (SWDO)** recommended to declare the affected areas as in a state of calamity;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the members of the 5<sup>th</sup> Sangguniang Panlungsod, to declare the area affected by the fire on **August 13, 2008** at **Magdaong Drive, NBP Reservation, Poblacion, Muntinlupa City**, as in a state of calamity.






