AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE MILLION PESOS (PH3,000,000.00) FOR FAMILIES AFFECTED BY THE FIRE ON MARCH 24, 2009 AT PUROK 2, PNR SITE, BAYANAN, MUNTINLUPA CITY WHICH AMOUNT SHALL BE TAKEN FROM THE 2009 EXECUTIVE BUDGET UNDER THE CALAMITY FUND.

WHEREAS, Section 458 (a)(l)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx, and":

(l)(iv) shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on March 24, 2009, there were houses gutted by the fire, in Purok 2, PNR Site, Bayanan, Muntinlupa City;

WHEREAS, the owner of the houses, renters, and sharers were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Welfare and Development Office (SWDO) recommended to declare the affected area as in **a state of calamity**;

WHEREAS, the 5th Sangguniang Panlungsod passed a Resolution No. 09-269, entitled, "A resolution declaring the area affected by the fire on March 24, 2009 at Purok 2, PNR Site, Bayanan, Muntinlupa City, as in a state of Calamity";

NOW THEREFORE, BE IT RESOLVE, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod duly assembled to appropriate the amount of **Three Million Pesos (Ph3,000,000.00)** for families affected by the fire on **March 24, 2009** at **Purok 2, PNR Site, Bayanan, Muntinlupa City** which amount shall be taken from the **2009 Executive Budget under the Calamity Fund.**


