ORDINANCE NO. 09-089

AN ORDINANCE PRESCRIBING REGULATORY FEES FOR THE ISSUANCE OF TRAFFIC CLEARANCES, CERTIFICATIONS AND OTHER DOCUMENTS ISSUED BY THE MUNTINLUPA TRAFFIC MANAGEMENT BUREAU (MTMB) AND FOR OTHER PURPOSES.

WHEREAS, Article 99(3)(i) of the Rules and Regulations Implementing the Local Government Code of 1991, provides that, *“the Sangguniang Panlungsod shall enact ordinances granting xxx and xxx, upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the city and pursuant to this legislative authority shall:*

(i)Fix and impose reasonable fees and charges for all services rendered by the city government to private persons or entities;

WHEREAS, Section 153, of Republic Act 7160 otherwise known as the New Local Government Code of 199, states that, *“Service fees and charges - Local Government Units may impose and collect such reasonable fees and charges for service rendered”;*

WHEREAS, the **MUNTINLUPA TRAFFIC MANAGEMENT BUREAU (MTMB)** has already issuing certification, clearances and other documents to the public but they are not imposing any payment for the said services rendered;

WHEREAS, the **MUNTINLUPA TRAFFIC MANAGEMENT BUREAU (MTMB)** is issuing numerous traffic clearances, certifications, permits, etc., to the applicants requesting for the following:

- a) Traffic clearances for private individual to open business, like junkshop, motor shops, car wash shops, and other businesses operating along the main thoroughfares of the City of Muntinlupa.
- b) Traffic Clearances for transport groups that applied for accreditation be submitted to the Sangguniang Panlungsod.

- c) Traffic Clearances for transport groups that applied for accreditation to be submitted to the Sangguniang Panlungsod.
- d) Traffic Clearance for transport groups for accreditation to put up a terminal to be submitted to the Sangguniang Panlungsod.
- e) Traffic Clearance for water service connection.
- f) Certifications fro drivers who secure personal records on apprehension (with or without record).
- g) Traffic Clearances for private companies/ and individuals to conduct motorcade and provide motorcycle escorts, etc.
- h) Traffic Clearances for excavation and installation.
- i) Traffic Clearances for private transport companies to move equipment and / or load with excessive weight, width or height.

WHEREAS, in order to compensate for these services and resources used by MTMB, it is but proper to impose certain fees and/or amount of these activities with the end in view of helping the City Government's revenue collection as hereunder enumerated;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 5th Sangguniang Panlungsod of Muntinlupa in Session assembled that:

SECTION 1. The *Muntinlupa Traffic Management Bureau (MTMB)* shall charge regulatory fees for every owner/operator of business, industrial, commercial establishments, and private entities building for issuance of any clearances, certificates, inspection and compliance monitoring. The said fee that will be imposed will generate funds that will supplement the operations and maintenance of the Muntinlupa Traffic Management Bureau (MTMB) programs and projects.

The Muntinlupa Traffic Management Bureau (MTMB) shall be a pre-requisite for the issuance of accreditation from Sangguniang Panlungsod and business permit subject to the conditions and policies of the Business Permits and Licensing Office.

SECTION 2. *Payment to the City Treasurer in accordance with the following schedule:*

I. *Traffic clearances to be issued for private business establishment before approval by BPLO:*

VII. **Traffic clearance for private transport groups to move equipment and/or load with excessive weight, width or height (in consonance with City Ordinance No. 04-022, Sec. 22, Sec. 92 – Muintinlupa Traffic Code).**

- As prescribed in the Muntinlupa Traffic Code, Section 92 before approval of MTMB.

SECTION 4. All fees collected pursuant to this Ordinance shall be divided as follows:

- a) **The Fifty percent (50%) shall go to the trust fund of Muntinlupa Traffic Management Bureau (MTMB) and the remaining Fifty Percent (50%) shall go to the General Fund of the City Government.**
- b) **All fees and charges that will accrue to the Muntinlupa Traffic Management Bureau (MTMB) Trust Fund will augment the funding of all programs and projects.**

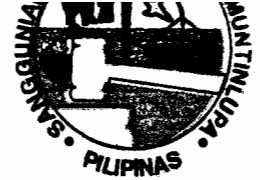
SECTION 5. Repealing Clause – All ordinances and resolutions or parts thereof which are inconsistent with the provisions hereof are hereby repealed or modified accordingly.

SECTION 6. Separability Clause – If, for any reason, any provision/s of this Ordinance shall be held unconstitutional by competent authority, such judgment or action shall not affect or impair the other provisions.

SECTION 7. Effectivity – This ordinance shall take effect immediately after publication in a local newspaper of general circulation.


