WHEREAS, under the Local Government Code of 1991, as amended, provides that, **"the City Council as the legislative body of the city has the power to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from the city funds"**;

WHEREAS, the **Pamantasan ng Lungsod ng Muntinlupa (PLMun)** which is under the City Government has a number of part-time faculty and staff who are entitled to additional allowance;

WHEREAS, in appreciation of their continued support to the quality tertiary education for the youth, it is necessary to grant them additional allowance in the amount of **Five Thousand Pesos (Php5,000.00)**;

WHEREAS, part time faculty and staff are entitled to additional allowance provided they have rendered six (6) months of active service from the time of hiring up to the present;

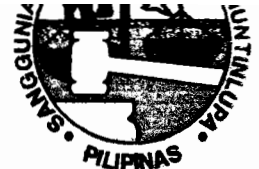
NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 5th Sangguniang Panlungsod in session as assembled that:

SECTION 1. This additional allowance amounting to **Five Thousand Pesos (Php5,000.00)** shall be given to each Part Time Faculty and Staff of **Pamantasan ng Lungsod ng Muntinlupa (PLMUN)**

SECTION 2. The additional allowance shall be paid by the **Pamantasan ng Lungsod ng Muntinlupa (PLMun)**.
