WHEREAS, there is a need to amend Section 1 (a.1.2) of Ordinance 08-042;

NOW THEREFORE BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 5th Sangguniang Panglungsod of Muntinlupa in session assembled that:

SECTION 1. Amending Section 1 (a.1.2) of Ordinance No. 08-042 otherwise known as the "Iskolar ng Bayan".

SECTION 2. Section 1 (a.1.2) of Ordinance No. 08-042 to be amended read as follows:

a.1. Qualifications;

a.1.2. Second Coverage: Second to Fourth year (2nd – 4th) studies only;

- General weighted average of at least 85%
- with no failing grade in the first year of studies as the case may be ;
- with no dropped subject in first year of studies as the case may be;
- with no incomplete grade in first year of studies as the case maybe;

SECTION 3. Section 1 (a.1.2) of Ordinance No. 08-042 be amended and shall now be read as follows:

a.1. Qualifications;

a.1.2. Second Coverage: Second to Fourth year (2nd – 4th) studies only;

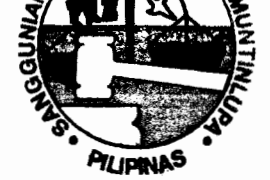
- General weighted average of at least 85%
- with no failing grade in the first year of studies as the case may be ;
- with no dropped subject in first year of studies as the case may be;
- with no incomplete grade in first year of studies as the case may be

However, any reasonable grade below the 85% General Weighted Average requirement shall be considered as may be determined and approved by the Board of Regents of the University, but in no case lower that 80% General Weighted Average and said consideration shall be applied to all levels.

SECTION 4. **Separability Clause.** If for any reason whatsoever, any section, clause or provision of this Ordinance is declared unconstitutional or inconsistent with any national law, other sections, clauses or provisions hereof which are not hereby affected, shall continue to be in full force and effect.

SECTION 5. Repealing Clause – All Ordinances or provisions thereof contrary to this Ordinance are deemed modified, repealed, and/or modified accordingly.

SECTION 6. Effectivity Clause. This ordinance shall take effect upon its approval.
