A RESOLUTION RECOMMENDING THE EXTENSION OF THE CONTRACT OF EXPEDITION CONSTRUCTION CORPORATION FOR THE GARBAGE HAULING AND DISPOSAL SERVICES FROM FEBRUARY 1, 2009 TO APRIL 30, 2009 OR FOR A PERIOD OF THREE (3) MONTHS UNDER THE SAME TERMS AND CONDITIONS OF THE ORIGINAL CONTRACT AT A CONTRACT PRICE OF TEN MILLION EIGHT HUNDRED SEVEN THOUSAND EIGHTY THREE PESOS AND 33/100 (PHP10,807,083.33) PER MONTH PENDING THE CONDUCT OF NECESSARY BIDDING PROCESS BY THE BIDS AND AWARD COMMITTEE (BAC) AND AUTHORIZING THE CITY MAYOR HON. ALDRIN L. SAN PEDRO TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT.

WHEREAS, the 5th Sangguniang Panlungsod passed **Resolution No. 08-064** entitled, "*Resolution authorizing the Hon. City Mayor Aldrin L. San Pedro to enter into a new contract in behalf of the City Government of Muntinlupa with Expedition Construction Corporation for garbage collection and disposal services for the year 2008 amounting to Ten Million Eight Hundred Seven Thousand Eighty Three Pesos and 33/100 (Php10,807,083.33) per month or with the total amount of One Hundred Twenty Nine Million, Six Hundred Eighty Five Thousand Pesos (Php129,685,000.00) from January 31, 2008 to December 31, 2008*";

WHEREAS, the contract for the garbage collection between the City Government and Expedition Construction Corporation had expired on January 31, 2009;

WHEREAS, the Expedition Construction Corporation wrote a letter to the City Government requesting to extend the contract and to increase the contract price by **thirty percent (30%)** because of increase in toll fees, dumping fees, wages/salaries, maintenance (lubricants, spare parts, labor), etc.;

WHEREAS, the City Government grants the request to extend the contract for **three (3) months** under the same terms and conditions but no increase in the original Contract Price pending the conduct of necessary bidding process by the **Bids and Award Committee (BAC)**;

WHEREAS, there is an approved appropriation for the collection of garbage under the General Fund in the 2009 Executive Budget in the amount of **One Hundred Sixty Nine Million Pesos (Php169,000,000.00)**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod of Muntinlupa to recommend the extension of the contract of **Expedition Construction Corporation** for garbage hauling and disposal services from **February 1, 2009 to April 30, 2009** or for a period of three (3) months under the same Terms and Conditions of the original Contract at a contract price of **Ten Million Eight Hundred Seven Thousand Eighty Three Pesos and 33/100 (Php10,807,083.33) per month** pending the conduct of necessary bidding process by the Bids and Award Committee (BAC) and authorizing the City Mayor Hon. Aldrin L. San Pedro to sign for and in behalf of the City Government.

APPROVED, by the 5th Sangguniang Panlungsod of Muntinlupa this 16th day of February, 2009, on its 65th Regular Session.


