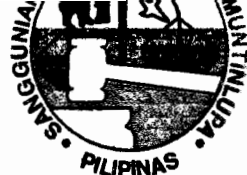

**WHEREAS**, Nonito Donaire was born on **November 16, 1982** at **Talibon, Bohol, Philippines** to Filipino parents, raised in **General Santos City**, and migrated to **California** at the age of ten (10).

**WHEREAS**, he is currently residing at **12 Bacolod St. Alabang Hills Muntinlupa City, Philippines;**

**WHEREAS**, Nonito became a successful amateur boxer having won the 2000 United States Amateur light flyweight championship title before turning professional;

**WHEREAS**, on September 9, 2002, Nonito Donaire won his first regional title by defeating Kaichon Sor Vorapin for the vacant WBO Asia Pacific flyweight title in Guam;

**WHEREAS**, on January 20, 2006, Nonito won his second regional title, the NABF super flyweight title, by defeating Kahren Harutyunyan on Shobox by split decision;

**WHEREAS**, on October 7, 2006, Donaire added the NABO super flyweight title and successfully defended it against veteran Oscar Andrade;

**WHEREAS**, on July 7, 2007, Nonito successfully wrested the IBF/ IBO world flyweight titles from the erstwhile undefeated, 7- time defending champion Victor Darchinyan of Australia via a spectacular 5<sup>th</sup> round knock out which earned him the recognition as "Knockout of the Year" and "Upset of the Year" by the prestigious Ring Magazine;

**WHEREAS**, Nonito was also named the 2007 "Most Outstanding Boxer of the Year" by the World Boxing Hall of Fame;

**WHEREAS**, on December 1, 2007, "The Filipino Flash" successfully defended his title against Luis Maldonado of Mexico by technical knockout in the 8th round in his first title defense to keep his IBF flyweight crown;

**WHEREAS**, on February 16, 2008, Manila, Philippines, Donaire received the Philippine Sports Award for 2007 Athlete of the Year;

**WHEREAS**, on November 2, 2008, Nonito retained his International Boxing Federation world flyweight title via a 6<sup>th</sup>-round technical knockout against Moruti Mthalane of South Africa;

**WHEREAS**, on April 19, 2009 Nonito successfully defended his IBF and IBO World Flyweight Title against the erstwhile undefeated challenger, Raul "La Cobrita" Martinez of Mexico via a spectacular 4<sup>th</sup> round TKO , at the Araneta Coliseum, Quezon City, Philippines;

**WHEREAS**, with all the aforementioned successes and achievements in boxing, Nonito Donaire brought honor and pride among Filipino people here and abroad;

**WHEREAS**, Nonito Donaire's achievement through hardwork, discipline and strong faith, served as an inspiration among the young and aspiring Filipino boxers in particular, and to the Filipino athletes and youth in general;

**NOW THEREFORE, be it resolved, as it is hereby resolved**, by the 5<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to recognize and honor the victorious achievement of Nonito "the Filipino Flash" Donaire Jr., for successfully defending his International Boxing Federation (IBF) and International Boxing Organization (IBO) World Flyweight titles for the third time against the erstwhile unbeaten Raul "La Cobrita" Martinez of Mexico via a spectacular fourth round TKO on April 19, 2009 at the Araneta Coliseum, Quezon City, Philippines.
