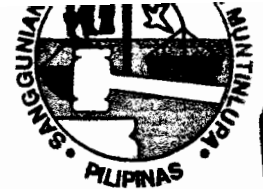

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod to approve Barangay Appropriation Resolution No. 56, Series of 2009, containing the Annual Budget of Barangay Butatan in the amount of *Thirty Three Million Fifty Thousand Pesos (Php33,000,050.00)* for Calendar Year 2009.
