NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod to approve Barangay Appropriation Ordinance No. 01-09, Series of 2009 containing the Annual Budget of Barangay Buli in the amount of **Nine Million One Hundred Sixty Six Thousand Nine Hundred Twenty One Pesos (Php9,166,921.00)** of Barangay Buli, Muntinlupa City for Calendar Year 2009.


