WHEREAS, the said Appropriation Ordinance was reviewed by the City Budget Office and was found to be **proper and in order**, having complied with the requirements setforth under the Local Government Code of 1991;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod to approve Barangay Appropriation Ordinance No. 09-002, containing a budget of Twenty Seven Million Two Hundred Ninety Seven Thousand Three Hundred Twenty Nine Pesos (Php27,297,329.00) of Barangay Sucat, Muntinlupa City for Calendar Year 2009.
