WHEREAS, Section 458 (a)1(i) of Republic Act 7160, otherwise known as the New Local Government Code of 1991, states that, *the Sangguniang Panlungsod as Legislative Body of the city, shall enact ordinances and approve resolutions xxx,*

(a) shall review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay”;

WHEREAS, the Barangay Ayala-Alabang complied with the required appropriation for the following statutory and contractual obligations in full: **10% for Sangguniang Kabataan, 20% Community Development Fund (CDF) and 5% for Calamity Fund;**

WHEREAS, **Barangay Ayala-Alabang** has a Annual Budget of Barangay Ayala Alabang in the amount of Fifty Eight Million Five Hundred Seventy Three Thousand Seven Hundred Forty Six Pesos (Php58,573,746.00) as per Barangay Appropriation Ordinance No. 12-006 series of 2008 for calendar year 2009;

WHEREAS, the said Appropriation Ordinance was reviewed by the **City Budget Office** and was found to be **proper and in order**, having complied with the requirements setforth under the Local Government Code of 1991;
