**WHEREAS**, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that, *"the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx, and"*:

**(1)(iv) shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.**

**WHEREAS**, on August 6, 2010, there were houses gutted by the fire, in Purok 4 Alabang, Muntinlupa City;

**WHEREAS**, the owner of the houses and renters were rendered homeless by reason of the said conflagration;

**WHEREAS**, the Social Welfare and Development Office (SWDO) recommended to declare the affected area as in **a state of calamity**;

**WHEREAS**, the 6<sup>th</sup> Sangguniang Panlungsod passed a Resolution No. 10-010 entitled, *"A resolution declaring the area affected by the fire on August 6, 2010 at Purok 4, Alabang, Muntinlupa City, as in a state of Calamity"*;

WHEREAS, the specific breakdown of the amount is as follows:

<i>House Renter (Totally Damage) -</i>	<i>Php2,000.00</i>

WHEREAS, there is an available fund from the 2010 Executive Budget under Calamity Fund of the City;

**NOW THEREFORE, BE IT RESOLVE, AS IT IS HEREBY RESOLVED,** by the Sangguniang Panlungsod duly assembled to appropriate the amount of **SEVENTEEN THOUSAND PESOS (PH17,000.00)** for families affected by the fire on **August 6, 2010** at **Purok 4, Alabang, Muntinlupa City** which amount shall be taken from the **2010 Executive Budget** under the **Calamity Fund**.

**ENACTED,** by the 6<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 23<sup>rd</sup> day of **August 2010**, on its 7<sup>th</sup> **Regular Session**.
