ORDINANCE NO. 10-011

AN ORDINANCE REQUIRING ALL CINEMA OWNERS/OPERATORS OPERATING WITHIN THE CITY OF MUNTINLUPA TO INCREASE THEIR CINEMA ADMISSION PRICE BY ONE PESO (PHP1.00) COVERING THE PERIOD FROM OCTOBER 1, 2010 TO DECEMBER 31, 2011 TO SUPPORT FEEDING PROGRAM TO MALNOURISHED SCHOOL CHILDREN IN THE PUBLIC ELEMENTARY SCHOOLS IN THE CITY OF MUNTINLUPA.

WHEREAS, it is a declared policy of the state to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Section 11 of the 1987 Constitution states that, "the State shall adopt an integrated and comprehensive approach to health development which endeavor to make essential goods, health and other social services available to all the people, xxx;

WHEREAS, the **Division Office** of the **Department of Education**, in the City of Muntinlupa has an existing **"feeding Program"** for malnourished school children;

WHEREAS, in order to make said project more extensive and to ensure continuity, the Division Office seeks aid and support from private sectors;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 6th Sangguniang Panlungsod in session assembled that:

SECTION 1. All cinema owners and operators operating within the City of Muntinlupa are hereby required to increase their cinema admission price by One Peso (Php1.00), covering the period from October 1, 2010 to December 31, 2011.

SECTION 2. Copy of this ordinance shall be posted in the cashier booth of the cinemas operating in the City of Muntinlupa to inform the moviegoers on the contents of the same.

SECTION 3. The remittance to the City Treasurer's Office by cinema owners and operators of all monies collected from the increase shall be made on a monthly basis, simultaneous with the payment of amusement tax.

SECTION 4. The City Treasurer's Office shall, within ten (10) days from receipt of all monies, inform the City Council in writing as to the exact amount the said office received from the cinema operators.

SECTION 6. The remittance made to the City Treasurer's Office pertaining to the amount collected from the cinemas shall accrue to a Trust Fund, the disbursement of which shall be recommended by the Division Office exclusively to support the feeding program for malnourished school children in public elementary school in the City of Muntinlupa, subject to the approval of the City Mayor and subject to mandatory auditing, accounting and all other procedures as may be required by law.

SECTION 7. This ordinance shall take effect upon its approval and only within the coverage period.

ENACTED, by the **6th Sangguniang Panlungsod of Muntinlupa** this **27th** day of **September, 2010** on its **11th Regular Session**.




