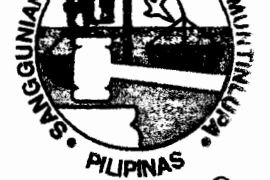

ORDINANCE NO. 10-014

AN ORDINANCE GRANTING CASH INCENTIVE AMOUNTING TO TWO THOUSAND PESOS (PHP2,000.00) EACH TO THE BARANGAY HEALTH WORKERS (BHW), KABALIKATSA KALINISAN, CONSULTANTS, CASUAL AND CONTRACTUAL EMPLOYEES OF THE CITY GOVERNMENT OF MUNTINLUPA WHO ARE NOT ENTITLED TO THE 13TH MONTH PAY IN THE TOTAL AMOUNT OF SEVEN MILLION FIVE HUNDRED THIRTY TWO THOUSAND PESOS (Ph7,532,000.00).

WHEREAS, the New Local Government Code of 1991, as amended, provides that, "the City Council as the legislative body of the city has the power to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from the city funds";

WHEREAS, DBM Circular No. 2005-6 dated October 28, 2005, provides the payment of 13th month pay and cash gift incentives to government employees and the said circular specifies government employees who are not entitled to 13th month pay;

WHEREAS, the City Mayor thru the Local Finance Committee has recommended to grant cash incentive amounting to Two Thousand Pesos (Php2,000.00) each to the Barangay Health Workers (BHW), Kabalik sa Kalinisan, Consultants, Casual and Contractual employees of the City Government of Muntinlupa who are not entitled to the 13th month pay;

WHEREAS, the City Government of Muntinlupa has a number of employees, assigned to various offices, who are not entitled to 13th month pay and they are the following:

- a) BHW - 413
- b) Kabalik sa Kalinisan - 1,057
- c) Consultants - 84
- d) Casual and Contractual Employees - 2,212

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED,
by the 5th Sangguniang Panlungsod in session as assembled that:

SECTION 1. A cash incentive amounting to *Two Thousand Pesos (Php2,000.00)* shall be granted to each *Barangay Health Workers (BHW), Kabalik sa Kalinisan, Consultants, Casual and Contractual* employees of the City Government of Muntinlupa who are not entitled to the 13th month pay.

SECTION 2. The cash incentive shall be given to the covered employees on or before December 2010.

SECTION 3. Appropriation - The City Government shall allocate funds from the 2010 Executive Budget for the cash incentive amounting to a total amount of Seven Million Five Hundred Thirty Two Thousand Pesos (Ph7,532,000.00) for the employees who are not entitled to 13th month pay in the Executive Budget.

SECTION 4. Effectivity Clause – This ordinance shall take effect after its approval.

ENACTED, by the 6th *Sangguniang Panlungsod of Muntinlupa* this 15th day of *November, 2010*, on its 16th *Regular Session*.


