AN ORDINANCE APPROPRIATING THE AMOUNT OF EIGHT MILLION PESOS (PH8,000,000.00) AS FINANCIAL ASSISTANCE TO THE FAMILIES AFFECTED BY THE FIRE ON DECEMBER 23, 2010 AT TUKLAS, EAST SERVICE ROAD, BARANGAY CUPANG, MUNTINLUPA CITY WHICH AMOUNT SHALL BE TAKEN FROM THE CALAMITY FUND OF THE 2010 EXECUTIVE BUDGET.

WHEREAS, Section 458 (a)(l)(iv), of the Local Government Code of 1991 states that, *"the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxxx and appropriate funds for the general welfare of the city and its inhabitants xxx, and"*:

(l)(iv) shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on **December 23, 2010**, there were houses gutted by the fire, in **Tuklas, East Service Road, Barangay Cupang, Muntinlupa City**;

WHEREAS, the owner of the houses, renters, and sharers were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Welfare and Development Office (SWDO) recommended to declare the affected area as in **a state of calamity**;

WHEREAS, the 5th Sangguniang Panlungsod passed a Resolution No. 10-030, entitled, "A resolution declaring the area affected by the fire on December 23, 2010 at Tuklas, East Service Road, Barangay Cupang, Muntinlupa City, as in a state of Calamity";

WHEREAS, the **Social Welfare and Development Office (SWDO)** of the City submitted to the Sanggunian Panlungsod a certified copy of the list of the homeowners, renters, sharer (totally damaged) in coordination with the **Barangay Chairman of Cupang**;

WHEREAS, there is a need for the City Government to give financial assistance to the aforesaid victims;

WHEREAS, there is an available fund from the Calamity Fund of the 2010 Executive Budget of the City;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 6th Sangguniang Panlungsod of Muntinlupa duly assembled, to appropriate the amount of **Eight Million Pesos (PH8,000,000.00)** as financial assistance to families affected by the fire on **December 23, 2010 at Tuklas, East, Service Road, Barangay Cupang, Muntinlupa City** which amount shall be taken from **Calamity Fund of the 2010 Executive Budget**.

ENACTED, by the 6th Sangguniang Panlungsod of Muntinlupa this **24th** day of **December 2010**, on its **3RD Special Session**.
