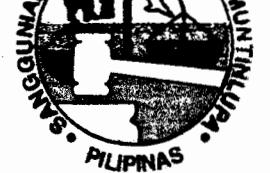

WHEREAS, Article III, Section 26 of Ordinance 09-085, enacted on April 13, 2009, by the 5th Sangguniang Panlungsod of Muntinlupa City, amended Article III, Section 26 of Ordinance 02-076 regarding ***"imposition of Amusement Tax on Admission"***;

WHEREAS, Article III, Section 26 of Ordinance 09-085 imposition of tax states that ***"there is hereby imposed an amusement tax to be collected from the proprietor of theaters, concert halls, circuses, boxing stadium, cockpits and other places of amusement at a rate of not exceeding thirty percent (30%) of the gross receipts from admission fee"***;

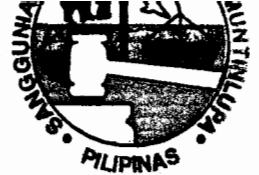
WHEREAS, Republic Act No. 9640, An act amending Section 140 (a) of Republic Act No. 7160, otherwise known as "the Local Government Code of 1991" states that, ***"the province may levy an amusement tax to be collected from the proprietors, lessees, or operators of theaters, cinemas, concert halls, circuses, boxing stadia, and other places of amusement at a rate of not more than ten percent (10%) of the gross receipts from the admissions fees,"*** which took effect starting September 2, 2009;

WHEREAS, Republic Act No. 9640 Section 2 Repealing Clause, states that, ***"all laws, executive orders, presidential decrees, ordinances, rules and regulations or parts thereof which are inconsistent with any of the provisions of this Act are hereby repealed, or modified accordingly"***;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED,
by the 5th Sangguniang Panlungsod of Muntinlupa in session assembled that:

SECTION 1. Article III, Section 26 of Ordinance No. 09-085 is hereby
amended,
and shall now be read as follows:

ARTICLE III
Amusement Tax on Admission

Section 26. Imposition of Tax. There is hereby imposed an amusement
tax to be collected from the proprietor of theaters, concert halls, circuses, boxing
stadium, cockpits and other places of amusement at a rate of not exceeding ten
percent (10%) of the gross receipts from admission fee."

day of February 2010, on its 107th Regular Session.
