WHEREAS, Section 192 and 459 (a) (xiii) of Republic Act 7160, otherwise known as the Local Government of 1991 provides that, "Local Government Units, through ordinances duly approved, grant tax exemptions, incentives or relief under such terms and condition as they may deem necessary";

WHEREAS, Republic Act No. 9640, An act amending Section 140 (a) of Republic Act No. 7160, otherwise known as "the Local Government Code of 1991" states that, "*the province may levy an amusement tax to be collected from the proprietors, lessees, or operators of theaters, cinemas, concert halls, circuses, boxing stadia, and other places of amusement at a rate of not more than ten percent (10%) of the gross receipts from the admission fees,*" which took effect starting **September 2, 2009**;

WHEREAS, Ms. Joanna a. Bacani, Logistic Team Head of Singles Encounter #16 Parish of Saint James the Great, Cuenca St., Ayala Alabang Village, Muntinlupa City sought the approval of the City Government of Muntinlupa, thru the Sangguniang Panlungsod for tax exemption for the movie premiere "Invictus" on February 16, 2010 at Festival Super Mall, Alabang, Muntinlupa City;

WHEREAS, Single Apostolate of St. James the Great Renewal Movement is a community of friends brought together by God's Love is a non-stock, non-profit organization and is organized solely for civic and charitable purposes, whose members are singles based in Muntinlupa City;


