AN ORDINANCE APPROPRIATING THE AMOUNT OF NINETEEN THOUSAND PESOS (PH19,000.00) FOR FAMILIES AFFECTED BY THE FIRE ON FEBRUARY 15, 2010 AT ABAQUIN COMPOUND, PUROK 4, ALABANG, MUNTINLUPA CITY WHICH AMOUNT SHALL BE TAKEN FROM THE 2010 EXECUTIVE BUDGET UNDER THE CALAMITY FUND.

**WHEREAS**, Section 458 (a)(l)(iv), of the Local Government Code of 1991 states that, *"the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxxx and appropriate funds for the general welfare of the city and its inhabitants xxx. and"*:

*(l)(iv) shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.*

**WHEREAS**, as reported by the Social Welfare and Development Office (SWDO) on *February 27, 2010*, there were two (2) houses gutted by the fire and four (4) families were affected by the fire in Abaquin Compound, Alabang, Muntinlupa City;

**WHEREAS**, the owner of the houses, renters, and sharers were rendered homeless by reason of the said conflagration;

**WHEREAS**, the Social Welfare and Development Office (SWDO) recommended to declare the affected area as in **a state of calamity**;

**WHEREAS**, the 5<sup>th</sup> Sangguniang Panlungsod passed a Resolution No. 10-360, entitled, *"A resolution declaring the area affected by the fire on February 15, 2010 at Abaquin Compound, Alabang, Muntinlupa City, as in a state of Calamity"*;




