AN ORDINANCE EXTENDING THE FILING/RENEWAL OF BUSINESS PERMITS AND THE PAYMENT OF ALL LOCAL TAXES, FEES AND OTHER CHARGES WITHOUT PENALTY FROM JANUARY 21 UP TO THE CLOSING HOURS OF JANUARY 31, 2011.

**WHEREAS**, Section 167 of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that, *“xxx all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case may be. The Sanggunian concerned may, for a justifiable reason or cause, extend the time of payment of such taxes, fees or charges without surcharges or penalties but only for a period not exceeding six (6) months;*

**WHEREAS**, the last day of renewal of business licenses on **January 20** was adopted pursuant to Section 169 of the Revenue Code of Muntinlupa;

**WHEREAS**, the letter request for the extension of filing/renewal of business permits without penalty from January 21 up to the closing hours of January 31, 2011 from the Business Permit and Licensing Office (BPLO) was submitted to the City Council dated January 19, 2011;

**WHEREAS**, there is a need to give ample time to taxpayers to file their payments for the renewal of business licenses in the City of Muntinlupa since the **Business One Stop Shop (BOSS)** will not be opened during Saturdays and Sundays;

**WHEREAS**, the City Government of Muntinlupa recognizes the increasing number of new registered businesses in the city;
