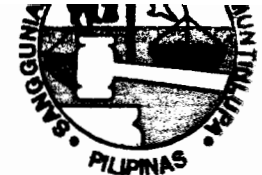

AN ORDINANCE GRANTING THE PRELIMINARY APPROVAL FOR LOCATIONAL CLEARANCE TO BAYAN TELECOMMUNICATIONS, INC., TO CONSTRUCT, INSTALL, MAINTAIN AND OPERATE AN EXISTING BTS/CDMA CELL SITE (30 M GUYED) FOR ITS WIRELESS LANDLINE EXPANSION PROJECT LOCATED AT LOT 27 BLOCK 3-1, JASMIN ST., RUBY PARK, VICTORIA HOMES VILLAGE, BARANGAY TUNASAN, MUNTINLUPA CITY.

NOW THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the 6TH Sangguniang Panlungsod of Muntinlupa in session assembled that:

SECTION 1. To grant the Preliminary Approval for Locational Clearance for the construction, installation and operation of **BAYAN TELECOMMUNICATIONS, INC.**, for communication antennae and other facilities located at *Lot 27 Block 3-1, Jasmin St., Ruby Park, Victoria Homes Village, Barangay Tunasan, Muntinlupa City.*

SECTION 2. The project of **BAYAN TELECOMMUNICATIONS, INC.**, will improve better services for their subscriber, especially in area where the cell site antennae will be constructed.

SECTION 3. The issuance of **Preliminary Approval for Locational Clearance (PALC)** shall be done provided that, they will comply, all required documents in local and national agencies;

SECTION 4. The contractor-applicant shall comply with all legal requirements by the Zoning Office, existing laws, rules and regulations and shall abide all provisions provided in Ordinance No. 10-114.
