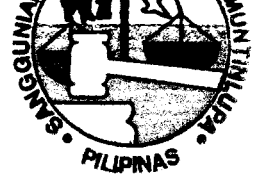

WHEREAS, the Sangguniang Panlungsod of Muntinlupa passed and approved Ordinance No. 02-076, entitled, "***an ordinance amending Ordinance No. 93-35, otherwise known as the Revenue Code of Municipality of Muntinlupa and adopting the new rates prescribed under this ordinance***";

WHEREAS, the Sangguniang Panlungsod of Muntinlupa also passed and approved Ordinance No. 02-052, entitled, "***an ordinance amending Section 87 and 88, Article II, Chapter II, of Ordinance No. 93-35, adopting a Revenue Code of the Municipality of Muntinlupa***";

WHEREAS, the Sangguniang Panlungsod of Muntinlupa also passed and approved Ordinance No. 09-085, that also amended Title II, Article II, Chapter II of Ordinance No. 02-052;

WHEREAS, the Committee on Ways and Means held a public hearing on May 4, 2011 on the request of the Local Civil Registry (LCR) regarding the continuation of Resolution No. 06-225, otherwise known as "***A Resolution providing for the holding of free delayed registration of birth and marriage by the Local Civil Registry Office of Muntinlupa City for the indigent constituents of the city***";

WHEREAS, Article 7 of the Convention on the Rights of the Child Provides that, "***the child shall be registered immediately after birth and shall have the right from birth to a name and the right to acquire a nationality xxx.***";

WHEREAS, Rule 12 of Administration Order No. 1 Series of 1993 otherwise known as, the Implementing Rules and Regulations of the Civil Registry Law, provides a legal opinion for children who are not registered to register under the delayed registration procedure;

WHEREAS, Proclamation No. 236 was issued by the **President of the Republic of the Philippines** declaring as national state policy, the free registration of births, deaths, marriage and founding;

WHEREAS, it was observed that most delayed registered births were those of children whose parents are not married at the time of their birth, and one of the legal barriers which affect the fulfillment of effective birth registration is poverty;

WHEREAS, the purpose of this ordinance is to continue the program of holding periodically a free delayed registration of birth and marriage by the Local Civil Registry Office that will benefit the indigent constituents of Muntinlupa City;

WHEREAS, the free delayed registration of birth shall apply only for those children born in the City of Muntinlupa;

WHEREAS, the applicant for free delayed registration of birth and marriage **shall first secure a certificate** from respective **Barangay** and a **Certificate of Indigency** for the **City Social Welfare Development (CSWD)** of the City to be eligible of the program;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the **6th Sangguniang Panlungsod of Muntinlupa** in session assembled that:

Title IV, Chapter II, Article II, Section 87 of Ordinance No. 09-085 is hereby amended and shall now be read as follows:

**TITLE IV
CHAPTER II
ARTICLE II**

Section 87. Imposition of Fees. The following fees shall be collected for services rendered by the Civil Registry.

a) Registration of Birth, Founding Marriage and Death	No Fees
b) Late registration (Processing Fee)	Php150.00
c) Marriage Application Fee	100.00
d) Marriage License Fee	200.00
e) Solemnization Fee	500.00
f) Filing of Supplemental Birth, Death and Marriage Certificate	75.00

Provided that, delayed registration of birth and marriage shall be free of charge for indigent constituents of the City of Muntinlupa.

Provided further that, such indigency be certified by the City Social Welfare Development Office and respective Barangay.


