AN ORDINANCE GRANTING THE PRELIMINARY APPROVAL FOR LOCATIONAL CLEARANCE TO SMART COMMUNICATION, INC., GLOBE TELECOMMUNICATIONS, INC., AND DIGITEL MOBILE PHILIPPINES, INC., TO CONSTRUCT, INSTALL, MAINTAIN AND OPERATE CELLSITE TOWER PROJECT LOCATED AT NARRA ST., AYALA ALABANG VILLAGE, BARANGAY AYALA-ALABANG, MUNTINLUPA CITY.

WHEREAS, the SMART COMMUNICATION, INC., GLOBE TELECOMMUNICATIONS, INC., and DIGITEL MOBILE PHILIPPINES, INC., is applying *Preliminary Approval for Locational Clearance* to maintain and operate cell site tower project located at NARRA ST., AYALA ALABANG VILLAGE, BARANGAY AYALA-ALABANG, MUNTINLUPA CITY.

WHEREAS, the SMART COMMUNICATION, INC., GLOBE TELECOMMUNICATIONS, INC., and DIGITEL MOBILE PHILIPPINES, INC., complied all the requirements setforth under Ordinance No. 99-023 as amended by Ordinance No. 99-033 and Ordinance No. 10-114;

WHEREAS, all adjacent communities interposed no objection for the construction and installation of communication antennae, and other facilities;

WHEREAS, after evaluating the necessary documents submitted by SMART COMMUNICATION, INC., GLOBE TELECOMMUNICATIONS, INC., and DIGITEL MOBILE PHILIPPINES, INC., and based on the recommendation of the City Zoning Administrator, the application for Preliminary Approval for Locational Clearance (LC) is hereby approved;

NOW THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the 6TH Sangguniang Panlungsod of Muntinlupa in session assembled that:

SECTION 1. To grant the Preliminary Approval for Locational Clearance for the construction, installation and operation of SMART COMMUNICATION, INC., GLOBE TELECOMMUNICATIONS, INC., and DIGITEL MOBILE PHILIPPINES, INC., for cell site tower project and other facilities located at NARRA ST., AYALA ALABANG VILLAGE, BARANGAY AYALA-ALABANG, MUNTINLUPA CITY.

SECTION 2. The project of **SMART COMMUNICATION, INC., GLOBE TELECOMMUNICATIONS, INC., AND DIGITEL MOBILE PHILIPPINES, INC.**, will improve better services for their subscriber, especially in area where the cell site tower will be constructed.

SECTION 3. The issuance of **Preliminary Approval for Locational Clearance (PALC)** shall be done provided that, they will comply, all required documents in local and national agencies.

SECTION 4. The contractor-applicant shall comply with all legal requirements by the Zoning Office, existing laws, rules and regulations and shall abide all provisions provided in Ordinance No. 10-114.




