RESOLUTION NO. 11-042

A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH PDJ INTEGRATED CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF COVERED COURT LOCATED AT CAMELLA HOMES IVB, POBLACION, MUNTINLUPA CITY IN THE AMOUNT OF SEVEN MILLION NINE HUNDRED THIRTY THOUSAND, THIRTY FIVE PESOS AND 23/100 (PHP7,930,035.23) WHICH AMOUNT SHALL BE TAKEN FROM THE INFRASTRUCTURE PROJECT UNDER EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the New Local Government Code of 1991, provides that, ***“the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”;***

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

WHEREAS, the construction of Covered Court located at Camella Homes IVB, Poblacion, Muntinlupa City, is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on **March 16 2010**, the City Government of Muntinlupa entered into Construction Agreement with **PDJ Integrated Construction** for the construction of the project amounting to Seven Million Nine Hundred Thirty Thousand, Thirty Five Pesos and 23/100 (Php7,930,035.23) as a result of a public bidding held on **March 10, 2010**;

WHEREAS, the **Construction Agreement** in consideration of the payments to be made by the City Government to **PDJ Integrated Construction** as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, on **March 11, 2010**, the Bids and Awards Committee (BAC) approved Resolution No. I-03-011-10, "declaring the **PDJ Integrated Construction** as the bidder with the Lowest Calculated Responsive Bid for the construction of Covered Court, at Camella Homes IVB, Poblacion, Muntinlupa City and recommend the approval by the City Mayor;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panglungsod to ratify the **Construction Agreement** entered into by the **City Mayor Hon. Aldrin L. San Pedro**, in behalf of the City Government of Muntinlupa with **PDJ Integrated Construction** for the project construction of **covered court** located at **Camella Homes IVB, Poblacion, Muntinlupa City** in the amount of **Seven Million Nine Hundred Thirty Thousand, Thirty Five Pesos and 23/100 (Php7,930,035.23)** which amount shall be taken from the Infrastructure Project under the Executive Budget.






