## **RESOLUTION NO. 11-042**

A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH PDJ INTEGRATED CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF COVERED COURT LOCATED AT CAMELLA HOMES IVB, POBLACION, MUNTINLUPA CITY IN THE AMOUNT OF SEVEN MILLION NINE HUNDRED THIRTY THOUSAND, THIRTY FIVE PESOS AND 23/100 (PHP7,930,035.23) WHICH AMOUNT SHALL BE TAKEN FROM THE INFRASTRUCTURE PROJECT UNDER EXECUTIVE BUDGET.

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the Construction Agreement for ratification;

WHEREAS, the construction of Covered Court located at Camella Homes IVB, Poblacion, Muntinlupa City, is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on March 16 2010, the City Government of Muntinlupa entered into Construction Agreement with PDJ Integrated Construction for the construction of the project amounting to Seven Million Nine Hundred Thirty Thousand, Thirty Five Pesos and 23/100 (Php7,930,035.23) as a result of a public bidding held on March 10, 2010;

WHEREAS, the Construction Agreement in consideration of the payments to be made by the City Government to PDJ Integrated Construction as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;
