AN ORDINANCE GRANTING THE PRELIMINARY APPROVAL FOR LOCALATIONAL CLEARANCE TO SMART COMMUNICATION, INC., GLOBE TELECOMMUNICATION, INC. AND DIGITEL MOBILE PHILIPPINES, INC., TO CONSTRUCT, INSTALL, MAINTAIN AND OPERATE CELLSITE TOWER PROJECT LOCATED AT GUAVA PARK, AYALA ALABANG VILLAGE, BARANGAY AYALA-ALABANG, MUNTINLUPA CITY.

WHEREAS, after evaluating the necessary documents submitted by SMART COMMUNICATION, INC., GLOBE TELECOMMUNICATION, INC. and DIGITEL MOBILE PHILIPPINES, INC., and based on the recommendation of the City Zoning Administrator, the application for Preliminary Approval for Locational Clearance (LC) is hereby approved;


