RESOLUTION NO. 11-043

A RESOLUTION RATIFYING THE AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH ANTOR GENERAL MERCHANDISE FOR THE SUPPLY AND DELIVERY OF MATERIALS FOR FABRICATION OF 1,500 PIECES TABLES TO BE USED AT VARIOUS SCHOOLS AT DISTRICT I AND II, MUNTINLUPA CITY IN THE AMOUNT OF THREE MILLION NINE HUNDRED TWENTY THOUSAND EIGHT HUNDRED SEVENTY FIVE PESOS (PHP3,920,875.00) WHICH AMOUNT SHALL BE TAKEN FROM THE INFRASTRUCTURE PROJECT UNDER THE EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the New Local Government Code, provides that, ***“the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”***;

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Agreement** for ratification;

WHEREAS, the supply and delivery of materials for fabrication of 1,500 pieces tables to be used at various schools at District I and II, Muntinlupa City, is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on **August 10, 2010**, the City Government of Muntinlupa entered into **Agreement** with Antor General Merchandise for the supply and delivery of materials for fabrication of 1,500 pieces tables to be used at various schools at District I and II, Muntinlupa City amounting to Three Million Nine Hundred Twenty Thousand Eight Hundred Seventy Five Pesos (Php3,920,875.00) as a result of a public bidding held on **August 4, 2010**;

WHEREAS, the **Agreement** in consideration of the payments to be made by the City Government to **Antor General Merchandise** as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, on **August 5, 2010**, the Bids and Awards Committee (BAC) approved Resolution No. 08-10-009, "*declaring the Antor General Merchandise as the bidder with the Lowest Calculated Responsive Bid for the for the supply and delivery of materials for fabrication of 1,500 pieces tables to be used at various schools at District I and II, Muntinlupa City*" and recommend the approval by the City Mayor;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod to ratify the **Agreement** entered into by the **City Mayor Hon. Aldrin L. San Pedro**, in behalf of the City Government of Muntinlupa with **Antor General Merchandise** for the supply and delivery of materials for fabrication of 1,500 pieces tables to be used at various schools at District I and II, Muntinlupa City in the amount of **Three Million Nine Hundred Twenty Thousand Eight Hundred Seventy Five Pesos (Php3,920,875.00)** which amount shall be taken from the Infrastructure Project under the Executive Budget.
