AN ORDINANCE GRANTING ADDITIONAL INCREMENT AMOUNTING TO FIVE HUNDRED PESOS (PHP500.00) EACH TO KABALIKAT, MEMBERS OF THE MUNTINLUPA CITY BAND, JOB ORDER (JO) AND BARANGAY HEALTH WORKERS (BHW) TO BE TAKEN FROM AVAILABLE FUNDS IN THE 2011 EXECUTIVE BUDGET.

WHEREAS, under the Local Government Code of 1991, as amended, it provides that, "the City Council as the legislative body of the city has the power to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from the city funds";

WHEREAS, DBM Circular No. 2005-6 dated October 28, 2005, provides the payment of 13th month pay and cash gift incentives to specified government employees only;

WHEREAS, the City Government of Muntinlupa has a number of employees, assigned to various offices, who are not entitled to 13th month pay, and they are the following:

- a) *Kabalikat* - 1,004
- b) *BHW* - 402
- c) *Job Order* - 262
- d) *Muntinlupa City Band* - 43

WHEREAS, the *Local Finance Committee* by virtue of Resolution No. 04, Series of 2011, recommended to grant additional increment amounting to **Five Hundred Pesos (Php500.00)** each to the *Kabalikat, Muntinlupa City Brass Band, Job Order (JO) and Barangay Health Workers (BHW)*.

WHEREAS, due to the difficult economic conditions at present, there is a need to grant additional increment in the amount of **Five Hundred (Php500.00)** each to the *Kabalikat, Muntinlupa City Brass Band, Job Order (JO) and Barangay Health Workers (BHW)*;

WHEREAS, these employees are already receiving the amount of **One Thousand Pesos (Php1,000.00)** cash incentive every December as they are not qualified to 13th month pay;

WHEREAS, the application for this payment is based on the preceding semesters qualification on employees hired on or before January 2, 2011 and must be in active service as of December 31, 2011;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the **6th Sangguniang Panlungsod** in session as assembled that:

SECTION 1. An additional increment amounting to **Five Hundred Pesos (Php500.00)** each shall be granted to the following: *Kabalikat, Members of the Muntinlupa City Brass Band, Job Order (JO) and Barangay Health Workers (BHW)*.

SECTION 2. The additional increment shall be given to the employees on or before December 2011.

SECTION 3. Appropriation - The City Government shall allocate the total amount of **One Thousand Five Hundred (Php1,500.00)** as cash incentive for the employees who are not entitled to 13th month pay which shall be given every December and which shall be taken from available funds in the Executive Budget of **every year**.

SECTION 4. All other ordinances inconsistent to this ordinance are hereby repealed or amended accordingly.

SECTION 5. Effectivity Clause – This ordinance shall take effect after its approval.

ENACTED, by the **6th Sangguniang Panlungsod of Muntinlupa** this **21st** day of **November, 2011**, on its **58th Regular Session**.
