A RESOLUTION EARNESTLY REQUESTING THE HOUSE OF REPRESENTATIVE THRU THE COMMITTEE ON CIVIL SERVICE AND PROFESSIONAL REGULATION TO FAST-TRACK THE PASSAGE OF SENATE BILL NOS. 3116 AND 3678 BOTH CONFERRING AN APPROPRIATE CIVIL SERVICE ELIGIBILITY UPON A MEMBER OF THE SANGGUNIANG BAYAN, SANGGUNIANG PANLUNGSOD, AND SANGGUNIANG PANLALAWIGAN WHO HAS SERVED THREE (3) CONSECUTIVE TERMS OF OFFICE.

WHEREAS, it has been a long clamor of the Municipal and City Councilors and Provincial Board Members for the conferment of an appropriate Civil Service Eligibility commensurate with their terms of office;

WHEREAS, the same benefit or incentive had already been granted to the Barangay Officials effectively since the enactment of the Local Government Code (Republic Act 7160);

WHEREAS, it has also been an advocacy of the Philippine Councilors League (PCL) that said eligibility be likewise conferred upon its more than 16,000 councilors nationwide, and hopefully be retroactive since the effectivity of the Local Government Code;

WHEREAS, it is now timely that these House of Representative Bill Nos. 3116 and 3678 have already been currently tackled in the Senate;

NOW THEREFORE BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod of Muntinlupa, earnestly requesting the House of Representative thru the Committee on Civil Service and Professional Regulation to fast-track the passage of House Bill Nos. 3116 and 3678 both conferring an appropriate civil service eligibility upon a member of the Sangguniang Bayan, Sangguniang Panlungsod, and Sangguniang Panlalawigan who has served three (3) consecutive terms of office.




